Subject: DDVP Use Information

The following information is provided to you from the Western Integrated Pest Management Center in response to your July 13, 2007 inquiry regarding the use of DDVP on beef cattle, dairy cattle, swine, and poultry. I am responding for the states of Idaho, Montana, Oregon, Utah, and Washington. (DDVP is not registered for use in Alaska.)

In all, I was able to come up with little useful information other than the following. It is estimated that 80% of the dairies in Utah's Cache County, home to 25% of Utah's dairy cows, use DDVP as either Vapona or Hot Shot. Clark Israelsen, Agriculture Agent with Utah State University, estimates that in Cache County, 80% of the dairy cows and 50% of the beef cattle are trerated with DDVP weekly from May through October and that producers seldom use more than five gallons per week. Animals are treated as a herd, not individually.

Other responses (or lack of same) to my inquiries varied as follows:

- Thought DDVP was not widely used (Washington beef cattle, Utah poultry, Oregon poultry)
- Thought DDVP was used but had no details (Montana beef cattle)
- Didn't know (Oregon beef cattle, Oregon dairy cattle, Oregon swine, Utah beef cattle)
- No response (Washington beef cattle, Washington dairy cattle)

I hope that you find this information useful. I am attaching a contact sheet for your use should you have further questions.
